The GIANT Gas and Groceries Giveaway Official Contest Rules

A complete copy of these rules can be obtained at the offices of radio station WNNK-FM/WINK 104, WQXA-FM/105.7, WWKL-FM/HOT 93.5, WZCY-FM/NASH FM 106.7, owned and operated by Cumulus Broadcasting LLC (collectively, the "Station"), 2300 Vartan Way, Harrisburg, PA 17110, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **GIANT Gas and Groceries Giveaway** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. No purchase is necessary. Void where prohibited. All federal, state, and local regulations apply.
- 2. Only legal U.S. residents age 18 or older with a valid Social Security number at the time of entry are eligible to participate in Station contests. Employees, agents, representatives, or affiliates of the Station, its affiliates, participating sponsors, other radio stations, television stations and print advertising companies serving the metro area, and their immediate family members and household members are not eligible to participate. The term "immediate family members" includes spouses, parents, siblings, grandparents, children, grandchildren and cohabiting significant others.
- 3. An individual may win an on-going contest only once per six-month period unless otherwise specifically stated. An individual may win other seasonal or one-time contests only once for the duration of the contest.
- 4. The contest will begin on **Monday**, **September 28**, **2015** and will run through **Friday**, **October 30**, **2015** (the "Contest Period").
- 5. <u>How To Play:</u> Every weekday during the contest dates of Monday, September 28, 2015 until Friday, October 30, 2015, between 7:00 and 7:35 AM the stations will announce the one hour window when the specific sounder or audio indicator will be played. When participants hear that station specific sounder or audio indicator, they will call the special contest number, 717-901-5427 (717-901-5GAS.) The 50th caller after the sounder is played in its entirety on all stations will win the prize of \$500 in free gas and groceries in the form of GIANT Food Stores gift cards (Monday, Tuesday, Wednesday and Friday only). Every Thursday during contest dates, the 50th caller after the sounder is played in its entirety on all stations will win the prize of \$1,000 in free gas and groceries in the form of GIANT Food Stores gift cards. All calls are answered in one central location and only one winner is chosen each weekday. Each participating station may use a different name for their contest and a different sounder or audio indicator; however each station will conduct the mechanics of the contest the same. Each participating station will conduct the giveaway at the same time each contest day and promote the same contest phone number.

<u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station mobile app, website, etc may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener winning this Contest may be diminished.

- 6. Each weekday during the contest period, one entrant will be selected as the potential winner by being caller #50 on the Gas and Groceries phone line. If it is determined that the candidate is not eligible to receive the grand prize, in the Station's sole judgment and discretion, another candidate will be selected for eligibility consultation and this process will continue on until such time as an eligible candidate is found. In the unlikely event that no candidates are found to meet the specifications, then the prize will go un-awarded. In the event of a tie, the winner will be determined by and at the Station's sole discretion.
- 7. <u>Prize(s):</u> \$500 GIANT Foods Gift Card and \$1,000 GIANT Foods Gift Card. Prizes are not transferable, redeemable for cash or exchangeable for any other prize, except in sole discretion of the station. All prizes must be redeemed within 30 days of the contest end date unless otherwise specified. If a winner cannot be contacted or is disqualified, the Company reserves the right to determine an alternate winner or not to award

that winner's prize, in its sole discretion. The Company is not acting as the manufacturer or distributor of any prize awarded. The Company makes no warranties with respect to any prize. With respect to any claims for cancelled, postponed, or rained out concert, sporting event or show ticket prizes, winner should look to the provider or others in the chain of production and distribution but excluding the Station and the Company.

- 8. All State, Local, Federal and or other taxes, duties, tariffs, title fees, licensing fees, or other fees for prizes awarded become the sole responsibility of the winner. All those who win a prize or prizes valued \$600 or more in any given year will be issued an IRS Form 1099 to report their winnings.
- 9. All prizes are awarded "as is." Prizes are nontransferable and cannot be exchanged. No substitute prize will be awarded to a winner who declines to accept a prize.
- 10. Odds of winning depend on a number of factors including the number of eligible entries received and listeners participating at any given time.
- 11. The Station shall not be responsible for the failure of participating sponsors to deliver the prizes or any part thereof as described herein.
- 12. All entrants and winners agree that the Station shall have no liability for any injury, misfortune, or damage to either persons or property incurred by entering, participating in, winning, or losing any contest and/or by the acceptance, use, or non-use of any prize received in connection with this contest.
- 13. All prizes must be claimed in person at the Station at the address identified above during regular business hours and within thirty (30) business days of winning, excluding holidays. After such time, ownership of said prize reverts back to the Station to be disposed of at its discretion. The winner then loses all claims and rights to said prize.
- 14. Proper identification must be presented by any winner to claim prize. As a condition to receiving the prize, any potential winner must complete and sign a Winner's Affidavit and Release, releasing the Station from all liability in connection with winner's participation in the contest and acceptance, use, or non-use of the contest prize.
- 15. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained on or within, shall become the sole property of the Station to be used, disposed of or destroyed in its sole discretion. The Station is not responsible for any incorrect or inaccurate information entered by website users, and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to the Station's website.
- All entrants and winners agree to give the Station and its licensees, affiliates, successors, and assigns the irrevocable and unrestricted right to use, re-use, broadcast, or publish their name, city of residence, photo, video tape, film or any other likeness, including portraits and pictures, in whole or in part, as part of a composite, retouched or distorted in character or form, and winner's voice, recorded or live, for any reason the Station deems necessary without compensation, unless prohibited by law. All winners release, discharge, and agree to hold the Station harmless from any and all claims they may have against the Station in connection with the taking, production, or the use of winners' name, city of residence, any photo, video tape, film or any other likeness, including portraits and pictures, in whole or in part, as part of a composite, retouched, or distorted in character or form and without restrictions as to any changes, transformations or alterations, and including winners' voices, recorded or live. All winners further acknowledge that the Station owns or will own exclusively any photographs of such winners used for such purposes, including the copyrights in them, regardless of the form in which they have been or may be produced and used, and all winners assign all such ownership rights to the Station.
- 17. By participating in the Contest, each participant agrees to receive email communications from the Station regarding Station events and contests. Any participant that opts-out of these mailings will also remove themselves from the contest. By participating in the Contest, where allowed by law, participants agree that

the Station may disclose personal information obtained from participants in the Contest to third parties and use such information for marketing and other purposes.

- 18. By participating in the Contest, participants agree to be bound by the decisions of Station personnel. Persons who violate any rule, gain unfair advantage in participating in the Contest, or obtain winner status using fraudulent means will be disqualified. Unsportsmanlike, disruptive, annoying, harassing or threatening behavior is prohibited. The Station will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest and the Station's decisions concerning such disputes shall be final. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Station, the Station reserves the right to terminate this Contest, or make such other decisions regarding the administration or outcome as the Station deems appropriate. All decisions will be made by the Station are final. The Station may waive any of these rules in its sole discretion. ANY ATTEMPT BY A CONTESTANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY CIRCUMVENT, DISRUPT OR DAMAGE ORDINARY AND NORMAL OPERATION OF THIS CONTEST, TELEPHONE SYSTEMS OR WEBSITES, OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, STATION RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PARTICIPANT TO THE FULLEST EXTENT PERMITTED BY LAW.

By participating in this contest, each participant agrees to waive any and all claims for damages for death, personal injury, loss of property or property damage that he or she may sustain as a result of his or her participation in the contest and/or the use of any prize, and any damages or losses arising from the implementation or carrying out of the contest or any participant's failure to win the contest or receive the prize, and to release Cumulus Broadcasting LLC, the Stations, and their parent companies, subsidiaries, affiliates, directors, officers, employees and agents from any and all liability arising out of or connected in any way with his or her participation in the contest, even though that liability may arise out of an intentional act, omission, negligence or carelessness on the part of the persons or entities mentioned above.
- 20. The Station reserves the right to limit the number of times an individual may enter a contest or drawing.
- 21. The Station reserves the right to require contestants to be present at drawings in order to win their prize.
