## WQXA'S "SVHD BIKE NIGHT RTW SUMMER OF LOUD CONCERT TICKETS JUNE 26, 2025" CONTEST OFFICIAL RULES

The Station will conduct the WQXA's "SVHD Bike Night RTW Summer Of Loud Concert Tickets June 19, 2025" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY. Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number. Void where prohibited by law. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Attend the remote broadcast conducted by Station at Susquehanna Valley Harley Davidson - 6300 Allentown Blvd., Harrisburg, PA 17112 on June 26, 2025 from 5:00 PM ET to 7:00 PM ET and complete an entry form. Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.

Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. **LIMIT ONE PRIZE PER PERSON.** 

## 4. Winner Selection.

Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial

verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

5. Verification of Potential Winner.
